Sir,

I invite your attention to Memorandum No.1/2-393/2011/Estt./17743-54 dated December 30, 2011 whereby Shri Parshotam Dass Goel was reemployed as Deputy Registrar (Accounts). The Finance Department vide communication dated January 19, 2012 directed the University to cancel the order regarding re-employment of Shri Parshotam Dass Goel, in view of provision of DoPT OM No.25012/2/97-Estt.(A) dated May 13, 1998 under which extension of employment/re-employment has been banned by Government of India.

In this connection, attention is also invited to para (VI) of the 'Pattern of Assistance' as communicated by the Department of Training & Technical Education vide letter No.S/Accounts/GIA/DTU/740-747 dated April 21, 2011. As per the said clause, all the posts in the Finance & Accounts Wing of DTU are required to be filled by officers of Accounts Cadre of the Government of NCT of Delhi / Government of India on deputation basis. There is no provision for re-employment under the said clause. In view of provision of GFR 209(2), the above-said restriction is binding on DTU, being a grantee institution.

Accordingly, the re-employment of Shri Parshotam Dass Goel, Deputy Registrar, may be terminated immediately under intimation to the Finance Department.

Further if the University has created posts, such creation salso not valid Only HE Lieutenant Governor is competent to allow creation of posts on proposals submitted through the Administrative and Finance Departments, since this imposes additional financial liabilities on the government. Details of such creation, if any, may also be provided.

I am afraid till compliance with the above, it may not be possible to release further grants to the University.

The agenda note is yet to be received; however, I would like to bring to your kind notice some important issues which need to be looked into by the Government:-

1. In the writ petition filed by Dr. MPS Mahendru, the Delhi Technological University and the Govt. of Delhi have taken different stands. However, as decided by the Chairman of the Committee constituted in this regard, a common stand is to be arrived at.

2. A PIL against the extension of the present Registrar of DTU has been filed by Shri G.S. Parwanda, Advocate challenging the decision taken by the Govt. of Delhi in respect of a fully Govt. funded University. An appropriate action for defending the matter before the Hon'ble High Court is to be taken as the case is coming up for hearing on 16.05.2012.

3. There are other issues which have come up in the wake of the reconstitution of Delhi College of Engineering into DTU which need to be resolved on

4. Certain amendments of DTU Act are under active consideration of Govt. of Delhi, to bring about a more comprehensive enactment for the University in the light of experience.

I shall be grateful if you could kindly defer the scheduled meeting of the Board of Management of DTU for the time being till the Govt. arrives at specific conclusions on the above cited important issues.
